The Private First-Class Desmond T. Doss VA Clinic Act, S.3938, is a bill introduced March 14, 2024, to designate the community-based outpatient clinic of the Department of Veterans Affairs in Lynchburg, Virginia. In the Senate, SEN Warner introduced, and SEN Kaine cosponsored. In the House, Rep Bob Good introduced a companion bill. Virginia Department Commander Sonnie Dickerson wrote a letter to Rep. Bob Good supporting this bill, as did the Virginia VFW Commander. Wonderful advocacy from the top!

We need you to contact your State Senators and Delegates. In a May 2024, special legislative session, the Virginia General Assembly made changes to the budgeting of the Virginia Military Survivors & Dependents Education Program that will adversely impact the beneficiaries. VMSDEP is a Commonwealth of Virginia program that provided eight college semesters of education benefits to spouses and children of qualifying Veterans including those disabled by military service, killed, missing in action, and taken prisoner. The breadth of the program and its eligibility was changed by the budget

amendments impacting multiple families. We have started advocacy to restore the benefits. Let me know if your dependents qualify, or in the past qualified, for VMSDEP. We need help to restore the benefits of this deserving program.

A JLC statement you may send to your representative is attached to this memorandum. See the next page for a sample email to your Delegate and Senator.

Delegate [name] or Senator [name] I am [name/brief description of self or military service]. I write on behalf of the American Legions Post xx, VA concerning the effect of the special session budget negotiations regarding VMSDEP. It appears that they relied on inaccurate data as to the cost of the program. A task force (Executive Directive Seven - 2024) has been created by the Governor to get correct data in regard to the impact. The Joint Leadership Council of Veterans Service Organizations has issued a statement (see attached) requesting that the Governor and General Assembly call a special session to postpone the upcoming changes to the VMSDEP Program. We request your support for this initiative so that students receiving the VMSDEP waiver in 2023-24 or who formally committed to an institution to enroll in the summer or fall 2024 courses will not be impacted by the changes in program eligibility." # BILLS SUPPORTED BY THE LEGION THAT PASSED IN 2024

March 6, 2024, Wednesday, the Military Construction, Veterans' Affairs, and Related Agency (MilCon-VA) appropriations passed through Congress as part of the Consolidated Appropriations Act, 2024. The MilCon-VA appropriations provides full funding for veterans' medical care, directs funding to state veterans' homes and VA research, and provides \$2 billion more than what was requested by the President for military construction. These projects will be focused on the Pacific theatre and on improving barracks. Additionally, over \$336 million will be allocated for child development centers and another \$88.6 million is allocated to the expansion of Arlington Cemetery.

Although the Elizabeth Dole Home Care Act of 2023, H.R.542, passed the House, as of April 19, 2024, there was no Senate agreement consolidating the Elizabeth Dole Home Care Act S. 141/H.R. 542 and the HOME Act which concerned homeless veterans. May 14, 2024, a bipartisan House and Senate Committee on Veterans' Affairs leaders introduced H.R. 8371, the Senator Elizabeth Dole 21st Century Veterans Healthcare and Benefits Improvement Act. The legislation includes bipartisan and bicameral proposals to reform and improve the delivery of healthcare, benefits, and services at the Department of Veterans Affairs (VA) for veterans, their families, and their survivors. It also includes a section "Housing our Military Veterans Effectively Act of 2023", or the "HOME" Act of 2023. The Senator Elizabeth Dole 21st Century Healthcare and Benefits Improvement Act did not advance to the House Floor before Memorial Day.

The Department of Housing and Urban Development (HUD) released its Annual Homeless Assessment. Report. According to HUD's findings, homelessness among veterans has risen over 7% in the past year: https://www.huduser.gov/portal/datasets/aha r/2023-ahar-part-1-pitestimates-of-homelessness-in-the-us.html.

H.R.3581 COPE Act (Caregiver Outreach and Program Enhancement Act), passed the House and was received in the Senate December 5th. Sponsored by Rep. Jen Kiggans (R-VA-2), the bill authorizes the Department of Veterans Affairs (VA) to award grants to implement, coordinate, improve, or enhance mental health counseling, treatment, or support for family caregivers of veterans participating in the family caregiver program.

The National Defense Authorization Act for 2025 May 22, 2024, the House version of the FY 2025 Servicemember Quality of Life Improvement and National Defense Authorization Act (NDAA) went to the House Floor after considering more than 700 amendments during a 12-hour markup. The bill adheres to the spending caps from last year's debt ceiling deal, allowing a 1% increase over the \$874.2 billion FY24 defense policy bill. The Senate Armed Services Committee is scheduled to take up its version of the legislation on June 12, 2024. While the legislation won't be in final form after these markups, it moves forward. Key provisions include the following:

Automatically register all male U.S. residents ages 18 to 26 into the Selective Service.

The annual statutory pap raise is 4.5% plus an additional 15% pay raise for E1 through E5 service members. The move would bring most service member's base pay to more than \$30,000 a year.

\$1.2 billion to housing allowances (bringing allowances to 100% of regional housing costs) and expands eligibility for the military's Basic Allowance for Subsistence stipend.

Create a Reserve Component Transition Assistance Program (TAP).

Language improving pay and benefits for Defense Department childcare workers, to help with recruiting and retention of those posts.

Not including the salary hike, the cost of the quality-of-life reforms total about \$4.2 billion, a significant section of the constrained authorization bill total.

#### PENDING LEGION PRIORITIES

Pending Bills supported by the Legion include:

The Afghan Adjustment Act, S.2327, streamlines the immigration process for the 150,000 Afghans applying for special immigrant visas and increase the level of vetting the applicants undergo. On February 6, 2024, TAL National Commander wrote to Congress urging its passage. The bill authorizes an additional 12,000 Afghan SIVs and extends the time that applicants can apply for the program by one year, until December 31, 2025. 07/13/2023 Read twice and referred to the Committee on the Judiciary.

The Contract Our Veterans Act of 2024, H.R. 7401, would require the Department of Defense to work with certain veteran-owned small businesses in procurement contracts. 02/15/2024 referred to the House Committee on Armed Services.

The Veterans Mental Health and Addiction Therapy Quality of Care Act, S.3546, addresses evaluations of the quality of mental health services at the VA and non-Department providers. Senate-12/14/2023 Read twice and referred to the Committee on Veterans' Affairs.

Expanding Home Loans for Guard and Reservists Act, H.R.6225, ensures that activated Reservists could easily receive home loans through the Post 9/11 GI Bill. House - 04/17/2024. Forwarded by

Subcommittee to Full Committee (Amended) by Voice Vote.

Pay Our Coast Guard Act, H.R.2693, was referred to the Committee on Appropriations on September 13, 2023. H.R.5641, the Pay Our Coast Guard Parity Act of 2023 had 66 co-sponsors and 04/19/2023 was referred to the Subcommittee on Coast Guard and Maritime Transportation. In the Senate, the Pay Our Troops Act, S.2791, 09/13/2023, was read twice and referred to the Committee on Appropriations. These Bills would make appropriations for Coast Guard pay in the event an appropriations Act expires, providing the same protection as the other U.S. Armed Forces branches.

Keep Our Border Agents Paid Act, S.2999, was referred on September 29, 2023, to the Senate Committee on Homeland Security and Governmental Affairs. TAL supports ensuring that U.S. Customs and Border Protection and U.S. Immigration and Customs Enforcement employees are paid during any government shutdown.

The Love Lives On Act, H.R. 3651, would allow Gold Star Spouses to keep their Gold Star benefits should they re-marry before age 55. 04/16/2024 forwarded by Subcommittee to House Committee on Veterans' Affairs.

The Expanding America's National Cemeteries Act of 2023, H.R.1413, would enable an existing VA-run national cemetery to transform into a new location capable of providing full military honors as ANC nears capacity. The Department of Defense (DoD) has proposed restricting Arlington eligibility primarily to recipients of awards such as the Purple Heart, Silver Star, or higher, potentially disregarding the service of deserving veterans from World War II, Korea, and the Vietnam era, as well as a sizable number of female veterans. House - 03/30/2023. Referred to the Subcommittee

on Disability Assistance and Memorial Affairs.

The Hello Girls Congressional Gold Medal Act, S.815/H.R.1572, would honor the female telephone operators of the Army Signal Corps. Senate - 03/15/2023 Read twice and referred to the Committee on Banking, Housing, and Urban Affairs. House - 03/14/2023 Referred to the Committee on Financial Services, and in addition to the Committee on House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee.

Protecting Veterans from Predatory Actors, H.R.1204, aims to protect veterans from predatory actors who vile Camp Lejeune and other claims for a fee or substantial percentage of recovery. Specifically, it caps attorney's fees at 12% of a payment made in an administrative claim, and 17% of a payment for a judgment rendered or a settlement entered in a judicial claim. House 02/27/2023 Referred to the House Committee on the Judiciary. S.378 - Senate 02/09/2023 Referred to the House Committee on the Judiciary.

The Governing Unaccredited Representatives Defrauding (GUARD) VA Benefits Act of 2023. S.740/H.R.1139, GUARD, would reinstate criminal penalties for unaccredited actors who charge unauthorized fees while assisting veterans with filing a claim for Department of Veterans Affairs (VA) disability compensation benefits. 04/26/2023 - Senate Committee on Veterans' Affairs. Hearings held. 03/29/2023 - House Subcommittee Hearings held.

An alternate bill, the PLUS Act of 2023, H.R.1822/S.1789 would reinstate criminal penalties, but legalize the practice of charging veteran fees up to \$12,500. The

Legion opposes the PLUS Act. House - 04/14/2023 PLUS Act Referred to the Subcommittee on Disability Assistance and Memorial Affairs. Senate - 06/01/2023 PLUS Act Read twice and referred to the Committee on Veterans' Affairs.

VET–TEC Authorization Act of 2023, H.R.1669, requires VA to permanently implement a program to provide veterans the opportunity to enroll in high technology programs of education and obtain non-degree training and skills related to computer programming, media application, data processing, or information sciences. Passed House. 05/30/2023 - Received in the Senate and Read twice and referred to the Committee on Veterans' Affairs

Veterans Entrepreneurship Training Act of 2023, H.R.1606, would authorize the Small Business Administration (SBA) to carry out the Boots to Business (B2B) Program over the 2023-2028 period. It allows entrepreneurship training to military service members (including the National Guard or Reserves), veterans, and their spouses and dependents. It also offers SBA grants to Veteran Business Outreach Centers for training.

The Military Spouse Hiring Act, S.596/H.R.1277, expands the Work Opportunity Tax Credit (WOTC) to permit employers to claim a tax credit for the portion of the wages paid the spouse. Military spouses frequently relocate. The bill aims to help them secure employment. As of February 9, 2024, the bill had the support of 143 lawmakers in the House and 47 in the Senate. SEN Kaine introduced the bill in the Senate and Rep. Don Beyer introduced it in the House. 03/01/2023 -Senate (47 co-sponsors) - Read twice and referred to the Committee on Finance. House-(146 co-sponsors). 03/01/2023 -Referred to the House Committee on Ways and Means.

The Military Family Protection from Debt Act, H.R.5190, aims to ensure that the Servicemembers Civil Relief Act, which caps interest rates for deployed servicemembers at 6%, can be extended to military spouses and dependents. House-11/02/2023 Subcommittee Hearings Held.

Major Richard Star Act, H.R.1282, is supported by most Congressional members. (70 co-sponsors in the Senate and 326 co-sponsors in the House). House-07/18/2023 Placed on the Union Calendar, Calendar No. 117.

PFC Joseph P. Dwyer Peer Support Program Act, H.R. 2768, would authorize the Secretary of Veterans Affairs to make grants to State and local entities to carry out peer-to-peer mental health programs. House - 07/18/2023 Subcommittee Consideration and Mark-up Session Held.

The TBI and PTSD Treatment Act, H.R. 105, would authorize VA to furnish hyperbaric oxygen therapy through a provider authorized by the Veterans Community Care Program to veterans who have a traumatic brain injury or post-traumatic stress disorder. 02/08/2023 - Referred to the Subcommittee on Health.

Department of Veterans Affairs Electronic Health Record Modernization Improvement Act, H.R.592, would prohibit VA from commencing an activity under the Electronic Health Record Modernization Program at a facility of the Veterans Health Administration until the VA certifies to Congress that the electronic health record system has met specified improvement objectives atceach facility where the system is being utilized as of the date of the enactment of this bill. House - 07/19/2023 Subcommittee Consideration and Mark-up Session Held.

The Not Just A Number Act, S.928, would require the Secretary of Veterans Affairs to

prepare an annual report on suicide prevention, and for other purposes. Senate - 07/12/2023 Committee on Veterans' Affairs. Hearings held.

The Veterans' Health Empowerment, Access, Leadership, and Transparency for our Heroes Act, S.1315, modifies the Veterans Community Care Program (VCCP), such as requiring the Department of Veterans Affairs (VA) to develop and implement plans to improve the administration of the VCCP. Senate - 07/12/2023 Committee on Veterans' Affairs. Hearings held.

The Military Family Nutrition Access Act, S.497, excludes military housing allowances from income when determining eligibility for the Supplemental Nutrition Assistance Program (SNAP). 02/16/2023 Introduced in Senate

The Veterans Service Recognition Act of 2023, H.R.4569, would allow noncitizen service members to apply for naturalization during basic, provide a review process for those in removal proceedings, and an opportunity for noncitizen veterans who have been removed, but not been convicted of serious crimes, to obtain legal permanent resident.

House - 07/12/2023 Referred to the Committee on the Judiciary, and in addition to the Committees on Veterans' Affairs, and Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.

Below is the status of the veteran Joint Leadership Council's supported bills. The Virginia General Assembly bills originate in both the House and Senate.

#### JLC EFFORTS: VIRGINIA VETERAN BILLS

Governor Directive Seven (2024)

HB 523. SB344 is its companion bill-Charitable Gaming. Amends charitable gaming law to allow, organizations receiving a charitable gaming permit or authorization to conduct electronic gaming, certain organizations to use a predetermined percentage of its receipts for expenses related to the rental of real property where such real property is involved in the operation of the organization and used for lawful religious, charitable, community, or educational purposes. DEL Paul E. Krizek, Chair ABC & Gaming subcommittee, sponsored. VOTE: Adoption (92-Y 4-N) Senate: Conference report agreed to by Senate (40-Y 0-N) Approved by Governor-Chapter 504 (effective 7/1/24).

HB 324, Goal 2 Action 2.4 (support relocated military families). Supports relocated military families by allowing spouse or children licensure in a different state. House: Passed (99-Y 0-N) Senate: Passed (33-Y 7N) Approved by Governor-Chapter 439 (effective - see bill -- The Compact has been passed in three states and takes effect when it is enacted by a seventh participating state or upon the effective date of the bill, whichever is later.

HB 326, the Social Work Licensure Compact, Goal 2. Action 2.4 (support relocated military families). Allows social workers eligible for an active, unencumbered license in the compact member state where they reside to apply for a multistate license in the other compact member states. House: Passed (99-Y 0-N) Senate: Passed (33-Y 7-N) Approved by Governor-Chapter 439 (effective - see bill Takes effect when it is enacted by a seventh member state).

HB 736, VFW-/JLC initiative as the Claims Sharks Veterans' Services Protection Act now HB 736, Sewell Veterans' Services Protection Act; prohibited practices; penalty. Department of Law; compensation for veterans' benefits matters; work group; report. Directs the Department of Law's Division of Consumer Counsel to convene a work group to examine and make recommendations regarding the practice of persons receiving compensation for preparing, presenting, prosecuting, advising, consulting, or assisting any individual regarding any veterans' benefits matter, as defined in the bill. Senate: Conference report agreed to by Senate (40-Y 0-N). House: Conference report agreed to by House (94-Y 1-N) Approved by Governor-Chapter 730 (effective 7/1/24).

HB 589, Office of Data Governance and Analytic; reciprocal data-sharing agreements. Goal 4 Action 4.5. (Share veteran-specific data to support data informed outreach plans for veterans.)
Passed House. Passed Senate. House: Passed (96-Y 0-N) Senate: Passed (40-Y 0-N)
Approved by Governor-Chapter 292 (effective 7/1/24)

HB 366, Virginia National Guard State Tuition Assistance Program. Goal 2. Action 2.3. Makes changes to the Guard State Tuition Assistance Program, including: (A) the provisions relating to the requirements and conditions for eligibility for and award of grants under the Program subject to regulations as prescribed by the Adjutant General; (B) eliminating the requirement to satisfy financial obligations with the institution of higher education at the beginning of each semester; (C) simplifies the requirements relating to academic performance and good standing; and (D) provides that upon acceptance, grant funds shall be disbursed to the applicable

institution of higher education for credit against the recipient's student account.

House: Passed (99-Y 0-N) Senate: Continued to 2025 in Finance and Appropriations (13-Y 2-N)

SB 4, HB 558 and SJR4, the Surviving Spouses provides for a referendum at the November 5, 2024, election to approve or reject an amendment to the Constitution of Virginia that would expand the real property tax exemption that is currently available to the surviving spouses of soldiers killed in action to be available to the surviving spouses of soldiers who died in the line of duty with a Line of Duty determination from the U.S. Department of Defense. House: Passed (98-Y 0-N) Senate: Passed (39-Y 0-N) Approved by Governor Chapter 394 (voter referendum)

SB 10, Reeves Income tax, state; subtraction for tax, military retirement benefits, uniformed services to include the United States Armed Forces, the commissioned corps of the National Oceanic and Atmospheric Administration, and the commissioned corps of the United States Public Health Service. Senate: Continued to 2025 in Finance and Appropriations (14-Y 0-N)

HB 1513, the Guard Medical Protections crossed over to Senate and referred to Committee on Finance and Appropriations—Active-duty status for any service member injured while in the line of duty. Provides that the Adjutant General may maintain state active-duty status for any service member injured while in the line of duty during a state active-duty mission who is unable to return to civilian employment for a period of up to 90 days after the date of the service member's injury. House: Passed (99-Y 0-N) Senate: Passed (39-Y 0-N). Approved by Governor-Chapter 226 (effective 7/1/24)

SB 229, the Vet Suicide Prevention, A Health Commissioner; workgroup made recommendations on Advisory Council on Breakthrough Therapies for Veteran Suicide Prevention. Directs the State Health Commissioner to establish a work group to examine the feasibility of and make recommendations for the placement and infrastructure of an Advisory Council on Breakthrough Therapies for Veteran Suicide Prevention. Senate: Passed (35-Y 5-N) House: Continued to 2025 in Rules.

SB 22, HB 225, Dentist and Dental Hygienist Compact; authorizes Virginia to become a signatory to the Compact. Applies to active-duty military. Senate: Passed (40-Y 0-N). House: Passed (98-Y 0-N) Approved by Governor-Chapter 31 (effective - see bill - the Compact has been passed in three states and takes effect when it is enacted by a seventh participating state or upon the effective date of the bill, whichever is later.)

SB 343, HB 619, Military centered community zones; localities may establish, by ordinance, one or more zones. Military centered community zones; local designation. Allows localities to establish, by ordinance, one or more military centered community zones, defined in the bill as a community that has a significant presence of military personnel living or working in the designated area and where such presence drives, or has the potential to drive, significant economic activity. The bill provides that a locality, or another political subdivision acting on behalf of the locality, may offer unique benefits to businesses looking to locate within a zone for the purpose of serving the needs of the military personnel, including reduction of certain fees and taxes. In addition, the bill provides that local governing bodies are authorized to enter into agreements for the payment of economic development incentive grants to such businesses. The bill also allows a governing body to provide for certain

regulatory flexibility and incentives and provides that the establishment of a military centered community zone shall not preclude the area from also being designated as an enterprise zone or from receiving support under the Virginia Military Community Infrastructure Grant Program House: Passed (94-Y 2-N) Senate: Passed (39-Y 0-N) Approved by Governor-Chapter 298 (effective 7/1/24)

#### What's Going on at your Post

# <u>Greenspring Post 123 – Commander Vance Morrison</u>

At Greenspring Village (the senior living community where our post is located), the Memorial Day Commemoration was jointly sponsored and conducted by Greenspring Post 123 and Greenspring's Community Resources staff. The theater was packed to its capacity of 250. Commander Vance Morrison welcomed the assembly and led the pledge of allegiance. Our color guard (Tom Doshier, Larry Swindell, and Ed Wyse) posted and later retired the colors. Member Les Burger, a former commander of Walter Reed Army Medical Center, was the guest speaker. Member Gray Parks with his guitar sang two ballads, Freedom Isn't Free (which he wrote) and Grand Old Flag. Judge Advocate Elizabeth "Libby" Hayes recited the poem In Flanders Field. Four members served as ushers and several others sang in the choir. In the lobby, Second Vice Commander/Chaplain Mickey Garverick and spouse Ruth set up and staffed a "missing man" display and Sergeant-at-Arms Tom Boltz and spouse Jean distributed poppies.

On May 14, sixteen people attended Veterans Having Coffee, a coffee klatch open to all resident veterans of Greenspring Village, that Post 123 sponsors monthly.

Our post proposes to place a display cabinet, interior lighted and on wheels, in a public space on the Greenspring campus to exhibit post memorabilia. This project has been approved by the Greenspring administration and now is being constructed by the Greenspring Woodshop. The cabinet will be dedicated appropriately upon completion.

#### <u>Falls Church Post 130 – Commander</u> Jamie Carl


